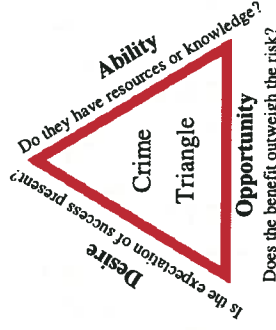

What is BOLO?

Businesses On the Look Out (BOLO) is a program offered by the Alachua County Sheriff's Office to businesses that travel throughout the community on a daily basis. These businesses are chosen because of their ability to observe streets, neighborhoods, and other businesses, much like a patrol deputy does. The BOLO program is an extension of the eyes and ears of law enforcement in the community. The BOLO program offers specialized training to its participants. These trainings provide participants with information on types of crimes, crime trends, and how to recognize and report crime.

What types of businesses can participate?

The BOLO program is looking for businesses that provide services throughout the community on a daily basis by way of a vehicle. This can include delivery and pick-up services, such as waste collectors mail carriers. It can also include utility companies, realtors, maintenance services, etc.



Business Watch

For businesses that do not have traveling employees, the Alachua County Sheriff's Office also provides Business Watch, a program much like a neighborhood crime watch except with businesses. Business crime watch groups can consist of businesses of similar nature, such as banks, gas stations, or hotel/motels, or it could include businesses in the same area, such as in a strip mall or shopping center. Members can be owners, operators, or employees. Business crime watch groups are trained by law enforcement to recognize and report suspicious people, vehicles, and incidents. Members also share crime prevention tips and tricks with each other specific to their customers and venue. This partnership between businesses and law enforcement promotes a collaborative approach to addressing crime in our area.

Benefits of BOLO and Business Watch:

- Promotes communication and understanding between law enforcement and the business community.
- Encourages cooperation between neighboring businesses and personnel.
- Teaches businesses to deter crime on their own properties and to watch over neighboring businesses and report any suspicious activity to law enforcement.
- Develops a business contact tree system for quick dissemination of information regarding criminal activity in the area. This system can be utilized through phone, email, or even social networking sites.
- Encourages the development of signals to activate in adjacent businesses when someone needs help.

Business Watch:

If you would like to join or form a business watch group, please follow these steps:

1. Contact the businesses you would like to include in your group to discuss their interest in joining.
2. Identify the people you would like to include (owners, operators, employees, etc.) and select three dates and times that would be best for everyone's availability.
3. Contact our Crime Prevention Unit at (352) 374-1800 to discuss these dates and times and arrange for a Crime Prevention Deputy to attend your meeting to discuss business watch and crime prevention practices.
4. A few days before the meeting, contact the members to remind them of the location, date, and time of the meeting.
5. Have at least 3 meetings with at least 50% of your group present in a 12 month period to form your official business watch group.

Crime Prevention Tip

Vehicles used for various types of jobs are often targets for burglary and vandalism. To help deter these types of crime, always lock the vehicle and park it in an area where there is adequate lighting and where the vehicle can be seen by the general public.
